**Breeders' Cup "Win and You're In" Challenge Race  
\$300,000 Guaranteed  
(Grade I)**

**FOR FILLIES, TWO YEARS OLD** By subscription of \$100 each if made on or before Thursday, September 17, 2015 or by supplementary nomination of \$6,000 at time of entries. All horses shall pay \$4,500 additional to start, with \$300,000 Guaranteed. The winner to receive \$180,000 PLUS \$40,000 in Breeders' Cup entry fees, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. 122 lbs. If this race oversubscribes, preference will be given in the following order: Graded Stakes winners, Graded Stakes placed, Stakes winners, total earnings at time of entry. The Chandelier Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Chandelier Stakes will be entitled to automatic entry into the 2015 running of the Breeders' Cup Juvenile Fillies. The nominated winner will be entitled to have pre-entry and entry fees waived for the Breeders' Cup Juvenile Fillies or will receive a credit equal to the Breeders' Cup Juvenile Fillies pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and will be entitled to receive a travel stipend if traveling from a base located outside the state of Kentucky. To be eligible for the 2015 Breeders' Cup Championships to be held at Keeneland on October 30 & October 31, 2015, all horses must be pre-entered by NOON (EST) at the designated pre-entry locations on Monday, October 19, 2015. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. A trophy will be presented to the owner of the winner.
