The added monies and all fees to be divided 60% to the winner, 20% to second, 12% to third, 6% to fourth and 2% to fifth. Weight 124 lbs. Non winners of \$40,000 since September 15 allowed 2 lbs. Non winners of \$30,000 since January 1 allowed 4 lbs. (Maiden, claiming and starter races not considered). Horses with the highest earnings at time of entry have preference after allowances. Starters to be named through the entry box by closing time of entries.
