All horses to pay \$2,250 additional to start, with \$150,000 guaranteed of which \$90,000 to the winner, \$30,000 to second, \$18,000 to third, \$9,000 to fourth and \$3,000 to fifth. Three-Year-Olds: 121 lbs. Older: 124 lbs. Non-winners of a Grade I or Grade II race at One Mile or Over since March 29, 2013, allowed 3 lbs. Non-winners of a Grade I or Grade II race at One Mile or Over OR Two Grade III races at One Mile or Over since September 29, 2012, 5 lbs. Highweights preferred, followed by Graded Stake Winners within 18 months of race, followed by Graded Stakes placed horses within 18 months of race, followed by highest earners within 12 months of race. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
