All horses to pay \$500 to pass the entry box and \$1,000 to start with \$100,000 guaranteed, of which \$60,000 to first, \$20,000 to second, \$12,000 to third, \$6,000 to fourth, \$2,000 to fifth. Three-year-olds: 120 lbs. Older: 123 lbs. Non-winners of a Graded Stakes since April 19, allowed 3 lbs. Non-winners of a Graded Stakes since October 19, 2012, 5 lbs. Highweights preferred, followed by Graded Stake Winners within 18 months of race, followed by Graded Stakes placed horses within 18 months of race, followed by highest earners within 12 months of race. Starters to be named through the entry box by the usual time of closing.
